

SUBJECT: 6 MG PETERS CANYON RESERVOIR – GEOTECHNICAL

EVALUATION PROJECT UPDATE AND BUDGET AMENDMENT

DATE: FEBRUARY 11, 2020

BACKGROUND

On December 15, 2020, during a routine inspection of the 6 MG Peters Canyon Reservoir, staff observed cracks in the CMU wall on the South and West sides of the reservoir. Due to the potential for slope failure and to ensure public health, safety, and District property were protected, staff contacted G3 Soilworks (G3) and authorized them under emergency basis to inspect the reservoir and embankment, install crack monitors, and develop a scope of work to perform an evaluation. G3 had installed monitoring wells in 2016, had recent knowledge of the site and subsurface conditions, and was available to respond quickly. Following the site visit, G3 recommended survey of the site to identify any abnormalities in the embankment and surrounding slopes. Staff contacted Sun Engineering (Sun) and awarded them a contract, in the amount of \$6,900.00, to complete a high-resolution Light Detection and Ranging (Lidar) survey of the reservoir (interior and exterior), the embankment, and the surrounding slopes on the South and West.

At a special meeting of the Engineering and Operations Committee on December 23, 2020, staff notified the Committee of the cracks, reviewed the actions taken to date, and reviewed G3's proposed scope of work for the geologic/geotechnical evaluation, in the amount of \$98,194.50. The Committee supported staff's recommendation to move forward with the evaluation and award a contract to G3. Subsequent to the meeting, staff decided it was in the District's best interest to continue the investigation with another firm due to G3's limited experience with dams and other factors. After considering a few firms, staff selected AECOM and awarded a contract to them under emergency basis in the amount of \$89,790.00. G3 had incurred costs in the amount of \$12,035.30 prior to the change.

FISCAL IMPACT

Funds in the amount of \$110,000.00 would be transferred from WZ Reserve Funds to Account 71038E1, 6MG Peters Canyon Reservoir Geotechnical Evaluation.

RECOMMENDATION

That the Committee recommend the Board amend the Wholesale Zone Capital Improvement Program Budget by adding Account 71038E1- 6MG Peters Canyon Reservoir Geotechnical Evaluation in the amount of \$110,000.
